SCOPE: To take medication felicitously and efficaciously in order to engender a maximal benefit.




Fig.1: Architecture Diagram

In this online prescription website, the admin, the receptionist and the doctor are the actors.





Fig.2: Home Page





Fig.3: Administrator Modules




Fig.4: Receptionist Modules




Fig.5: Doctor module
